**Re: *New Jersey v. Delaware*, No. 134 Original:
Delaware's Eighth Progress Report**

Dear Mr. Lancaster,

Pursuant to the Case Management Plan as amended, we respectfully submit Delaware's eighth progress report on the status of the case.

Since the last progress report, filed on September 5, 2006, Delaware has continued its search for relevant historical and legal documents. The parties have also served discovery responses, supplemented discovery, exchanged correspondence, and conferred regarding discovery issues set forth below.

- On September 6, 2006, Delaware requested deposition dates for eight New Jersey witnesses. Delaware also identified five additional witnesses that might present evidence in the case.
- On September 8, 2006, New Jersey provided supplemental document production to Delaware. The parties also served responses to requests for admissions. New Jersey additionally requested deposition dates for eleven Delaware witnesses.
- On September 11, 2006, New Jersey wrote Delaware objecting to Delaware's request to depose an attorney witness (William Andersen) who previously submitted a declaration in the case.¹

- On September 12, 2006, Delaware provided New Jersey with deposition dates for nine of the eleven witnesses requested for deposition by New Jersey.
- On September 12, 2006, New Jersey identified five additional witnesses that may present evidence in the case, and served Delaware with affidavits by three of those witnesses.
- On September 13, 2006, the parties held a meet and confer, and New Jersey provided Delaware deposition dates for seven New Jersey witnesses.
- On September 14, 2006, New Jersey submitted a letter to Delaware alleging certain deficiencies in Delaware's request for admission responses. Also on September 14, 2006, Delaware confirmed by letter several deposition dates and summarized the discussions of the September 13, 2006 meet and confer.
- On September 14, 2006, Delaware provided New Jersey supplemental production. The parties also held a meet and confer about expert discovery, deposition scheduling, and New Jersey's request to extend the fact discovery schedule by one week.
- On September 15, 2006, Delaware wrote to New Jersey confirming deposition dates and agreements reached regarding expert discovery at the meet and confer held on September 14, 2006. Delaware also requested deposition dates for two witnesses first identified by New Jersey on September 12, 2006.²
- On September 18, 2006, New Jersey provided supplemental document production to Delaware.
- On September 19, 2006, Delaware responded to New Jersey's September 14, 2006 letter relating to Delaware's responses to requests for admissions.
- On September 19, 2006, Delaware provided New Jersey a deficiency letter relating to New Jersey's responses to Delaware's requests for admissions. New Jersey also requested that Delaware identify by title or index the documents contained within Delaware's September 14, 2006 production.

depositions of Mr. Andersen, Mr. Maloney, and Mr. Trostle until after certain fact witnesses are deposed.

In addition, New Jersey filed a request with the Special Master to extend the fact discovery cut-off to October 20, 2006.

- On September 20, 2006, New Jersey provided another supplemental document production to Delaware. Delaware also provided New Jersey a document identification chart requested in New Jersey's September 19, 2006 letter. Additionally, Delaware provided New Jersey deposition dates for certain Delaware witnesses, and reiterated its request for deposition dates for two additional New Jersey witnesses. *See* fn. 2. On September 20, 2006, the Special Master entered Case Management Order No. 11, extending the fact discovery cut-off to October 20, 2006.
- On September 21, 2006, Delaware noticed the depositions of New Jersey witnesses for the dates agreed to by the parties.
- On September 22, 2006, New Jersey noticed the depositions of Delaware witnesses for the dates agreed to by the parties.
- On September 24, 2006, New Jersey canceled the depositions of two Delaware witnesses. The depositions, scheduled for September 25, 2006, were canceled because the attorney scheduled to take the depositions became ill.³
- On September 25, 2006, New Jersey provided a response to Delaware's September 19, 2006 deficiency letter on New Jersey's responses to requests for admissions.
- On September 26, 2006, New Jersey deposed Delaware witness William Streets. Delaware also provided supplemental document production to New Jersey.
- On September 27, 2006, Delaware deposed New Jersey witness Kevin Broderick.
- On September 28, 2006, the parties met and conferred about Delaware's document production and regarding New Jersey's intention to seek an extension of the discovery schedule. At that time, over Delaware's objection, New Jersey canceled the deposition of one of its witnesses, Ruth Ehinger, which was scheduled for the next day, September 29. New Jersey also advised Delaware that it would not appear for the September 29, 2006 deposition of Philip Cherry and that it was canceling depositions scheduled for the following week. Delaware advised New Jersey that it

believed that New Jersey's unilateral adjournment of the deposition scheduled was in violation of the Federal Rules and contrary to the Case Management Plan. New Jersey sought the assistance of the Office of the Special Master, which directed the parties to provide written position statements at noon (New Jersey) and 5:00 p.m. (Delaware) on September 29.

- On September 28, 2006, New Jersey provided supplemental document production to Delaware.
- On September 29, 2006, the parties submitted their position statements in accordance with the order of the Special Master.
- On October 2, 2006, Mark Porada of the Office of the Special Master advised that, during the conference call scheduled for tomorrow, each party should be prepared to discuss in detail which documents from the recent productions were not previously produced or otherwise in the opposing party's possession. Attached as Exhibit "A" is a chart setting forth in detail the contents of Delaware's September 26, 2006 document production. The chart also sets forth whether the documents were previously produced or are otherwise already in New Jersey's possession.

New Jersey has not provided deposition dates for two witnesses, Carl Wentzel and Beth Reddy. In addition, New Jersey has not produced aerial photographs referenced in New Jersey's request for admission responses, as promised in its September 25, 2006 letter. Because New Jersey canceled scheduled depositions, the depositions of two Delaware witnesses (Philip Cherry and David Small), and one New Jersey witness (Ruth Engler), will need to be rescheduled.

As noted in Delaware's letter of Friday, September 29, Delaware opposes an extension of the October 20, 2006 fact discovery deadline, or any extension of other dates in the current scheduling order. As the enclosed chart demonstrates, and as Delaware told New Jersey before depositions were unilaterally cancelled, almost none of Delaware's recent production would be useful at the depositions. Of the pages that might conceivably be relevant in depositions, totaling 257, those pages could have been reviewed in less time than was taken last week to bring this issue before the Special Master. A larger set of 1298 pages of documents produced by Delaware on September 26 consist primarily of (1) historical documents, (2) maps or photographs, or (3) publicly available news articles; and an even larger set of approximately 4721 pages are of documents already within New Jersey's possession (but produced by Delaware to create a complete record of documents for this case).

The limited nature of Delaware's supplemental document production does not justify a two month extension for all submissions on the current schedule. New Jersey has offered no justification for a seven-week extension for the submission of expert



reports. It can certainly claim no need for such an extension based on Delaware's September 26th production of documents, which in all respects comports with the Case Management Plan (*see* ¶ 14). Although we do not believe New Jersey has offered any justification for amending the schedule, we respectfully submit that only those deadlines that are materially affected by Delaware's recent production of documents should be amended.
