> Re: Becerra v. Texas, No. 23-1076 Motion for Extension of Time

Dear Mr. Harris,

Pursuant to Supreme Court Rule 30.4, Respondents American Association of Pro-Life Obstetricians & Gynecologists and the Christian Medical & Dental Associations request that the time in which to file their brief in opposition in the above-referenced case be extended for 32 days, until July 22, 2024.

On May 20, 2024 this Court requested a response to the petition for a writ of certiorari by June 20, 2024. Counsel for the American Association of Pro-Life Obstetricians & Gynecologists and the Christian Medical & Dental Associations seek a 32-day extension of time in which to file their brief in opposition due to the press of other litigation deadlines as follows:

- An opening brief in the 7th Circuit on June 3, 2024 in *E.D. v. Noblesville School District*, No. 24-1608;
- A reply brief in this Court on June 4, 2024 in *National Religious*Broadcasters Noncommercial Music Licensing Committee v. Copyright
 Royalty Board, No. 23-927; and

• An amicus brief in the 4th Circuit on June 19, 2024 in *Barnett v. INOVA*, No. 24-1271.

Granting Respondents' request will not cause prejudice to Petitioner as the extension will still permit the case to be distributed for the opening conference during the October term 2025. This is Respondents' first request for an extension. Petitioner does not oppose the requested extension.

For these reasons, Respondents request that the time in which to file their brief in opposition be extended for 32 days, until July 22, 2024.
