Per Curiam:*

Leroy Hoyle pleaded guilty to possession of a firearm by a convicted felon, in violation of 18 U.S.C. § 922(g)(1). He argues for the first time on appeal that § 922(g)(1) violates the Second Amendment and exceeds Congress's power under the Commerce Clause.

Because Hoyle did not raise his constitutional arguments in the district court, our review is limited to plain error. See United States v. Howard, 766 F.3d 414, 419 (5th Cir. 2014). To prevail on plain error review, Hoyle must show a forfeited error that is clear or obvious and that affects his substantial rights. See Puckett v. United States, 556 U.S. 129, 135 (2009) (citations omitted). If he makes such a showing, this court has the discretion to correct the error but only if it seriously affects the fairness, integrity, or public reputation of judicial proceedings. Id.

Hoyle's Second Amendment argument is based on *New York State Rifle & Pistol Ass'n v. Bruen*, 597 U.S. 1 (2022). However, such a plain error challenge to § 922(g)(1) is unavailing because, given the current state of the caselaw, it is not clear or obvious that § 922(g)(1) is unconstitutional. *See United States v. Jones*, 88 F.4th 571, at 573–74 (5th Cir. 2023).

Last, Hoyle asserts that § 922(g)(1) is unconstitutional because it exceeds Congress's authority under the Commerce Clause. We have consistently upheld the constitutionality of § 922(g)(1) and have labeled this statute "a valid exercise of Congress's authority under the Commerce Clause." United States v. Alcantar, 733 F.3d 143, 145 (5th Cir. 2013).

AFFIRMED.

Pursuant to United States Sentencing Commission, Guidelines Manual, §5G1.3(c) (Nov. 2018), it is the Court's intent for the sentence to run concurrently with any sentence imposed in Case Nos. F-2159252, F-2159253, and F-2159254 in the Dallas County Criminal District Court 6 and Case Nos. MA2162166 and MA2162167 in the Dallas County Criminal Court 8 which are related to the instant offense, and for the defendant to receive a sentence adjustment to account for any time spent in custody beginning on November 30, 2021, that the Bureau of Prisons will not credit under 18 U.S.C. §3585(b). - You must allow the probation officer to visit you at any time at your home or elsewhere, and you must permit the probation 6. officer to take any items prohibited by the conditions of your supervision that he or she observes in plain view.
- You must work full time (at least 30 hours per week) at a lawful type of employment, unless the probation officer excuses you 7. from doing so. If you do not have full-time employment you must try to find full-time employment, unless the probation officer excuses you from doing so. If you plan to change where you work or anything about your work (such as your position or your job responsibilities), you must notify the probation officer at least 10 days before the change. If notifying the probation officer at least 10 days in advance is not possible due to unanticipated circumstances, you must notify the probation officer within 72 hours of becoming aware of a change or expected change.
- You must not communicate or interact with someone you know is engaged in criminal activity. If you know someone has been 8. convicted of a felony, you must not knowingly communicate or interact with that person without first getting the permission of the probation officer.
- If you are arrested or questioned by a law enforcement officer, you must notify the probation officer within 72 hours.
- 10. You must not own, possess, or have access to a firearm, ammunition, destructive device, or dangerous weapon (i.e., anything that was designed, or was modified for, the specific purpose of causing bodily injury or death to another person such as nunchakus or tasers).
- 11. You must not act or make any agreement with a law enforcement agency to act as a confidential human source or informant without first getting the permission of the court.
- 12. If the probation officer determines that you pose a risk to another person (including an organization), the probation officer may require you to notify the person about the risk and you must comply with that instruction. The probation officer may contact the person and confirm that you have notified the person about the risk.
- 13. You must follow the instructions of the probation officer related to the conditions of supervision.
