Due to the Sworn Statement to follow, I may need another extension due to government interference and a blatant denial of critical emergency medical attention here within the custody of the U.S. Attorney General at USP Vicksburg.

I, Lamont Fitch, declare:

1. The U.S. government has specifically denied the Unit (5A) I'm housed on access to the Commissary to buy legal Supplies (Stamps and envelopes) and hygiene. This was strategically done, and no legal Supplies are being provided by Federal Staff here at US, Victorville.
2. I've been in excruciating pain for months now, with on and off dizzy spells, and the government has blatantly denied me emergency medical treatment as Medical Staff coordinates with Custody to retaliate against me.
3. In May of 2022 a mass the size of a small stone was found in my left testicle. An Ultrasonographer stated in a medical report that the "mass [is] suspicious with characteristics consistent with malignancy." Medical Staff provided me with no follow-up nor treatment;
4. Since the Ultrasonographer's finding in 2022, my left testicle has grown to the size of a melon, causing me a tremendous amount of pain in unexpected spurts, with an ever present ache and discomfort at the base, or in the area between my scrotum and rectum;
5. Since April 5, 2024 Medical provider Putney Cullen (Mowd) PA-C has attempted to directly admit me at the local hospital, the govern-



ment has interfered, providing me with absolutely no medical attention, while custody and unit team members plot against my person.

6. In conjunction with the untreated Molen size left testicle, I now suffer from Stage 3a Chronic Kidney disease. I went from Stage 2 to Stage 3 with no medical attention, or even notification, for this;
7. Last year I found that someone in the Medical Department switched my Amlodipine blood pressure medication with Aspirin. I filed complaint with SIS
8. For approximately 2 years the government has deliberately not treated my serious medical issues, withheld my medical records; and, again, recruited medical personnel in a campaign against me.
9. On June 26, 2024 I reported to medical in pain and requested to see the P.A.-C, Putney, C. He again attempted to admit me to the hospital, having me wait in the reception area for approximately 3 hours, where custody came through, harassed me, and then made me return to my unit;
10. Later this same day, during the evening watch, SIA Scott-Javis instructed that I be taken to the hospital. After she left, medical staff Medical took my blood pressure and returned me to the unit.

11. USP Vicksburg went on "lock-down" at this time. During "lock-downs" there's no "Sick-call" nor refills on medications. This caused Mitchell Boulder to commit suicide, slashing his throat after repeated requests for his medication and medical attention.

12. On July 5, 2024 I exhibited my condition to Deputy Captain C. Gore and asked to be taken to the hospital. He said he'd look into it.

13. On July 8, 2024 I complained to Warden J. Overe and requested to be taken to the hospital. He scanned my ID into his phone and told me OK. After I left the Warden, an Officer believing I was concealing contraband, roughed-up my inflated left testicle. I was escorted to medical by Sympathetic Compound Officers. Again, I waited in the reception area of the Medical Department for approx. 2 1/2 hours waiting for Doctor Peikar, Nader (M.D.) M.D. who never showed. I was returned to my Unit by Officer Hernandez who stated I was "basically waiting for no one." I contacted my family.

14. On July 9, 2024 I was summoned by Doctor Peikar, Nader, who wrote my name down on a paper towel, after examining my left testicle. A suicidal inmate came through so he had to address him. Dr. Peikar had me return to my Unit stating he'd call for me. This has not occurred as of this sworn statement.




15. Prior to this, Medical Records N. Turner provided me with an incomplete copy of my medical records from 2022 to the present. She withheld medical records as to my last encounter with Putney, C. (MOW) PA-C on June 26, 2024, and the medical records as to the finding of a nodule in my left lung.

16. There is a conspiracy to deny me medical attention, with Dr. Pei Kar at the helm, and I am suffering severe debilitating pain and dizziness regularly.
