2nd Motion for An Extension of Time to File

On May 7, 2024, Justice Thomas gratefully granted the 1st extension of time for me to file up to June 12, 2024.

However, after the 5/30/2024 US Supreme Court Distribution Conference for my Motion of Reconsideration, 6/3/2024 was a very unfortunate day for me and my case, as it was shown on the US Supreme Court Website my **Motion for Reconsideration to Proceed in forma pauperis (without payment)** was **Denied**. As a result of this final denial decision for Reconsideration for me to be granted and allowed to proceed *in forma pauperis*, I am now forced to have to pay a court filing fee of \$300.00 **in addition to**, the costs and expenses for 40 books which unfortunately, financially I do not have readily available at my disposal, as I have previously attested to in my initial filing of the Writ of Certiorari and my Motion for Reconsideration to Proceed in forma pauperis. **Because** the necessary funds needed for the expenses for me to proceed with my case would have to be sought/somehow raised, I would need more time to file.

Additionally, it is my hope that the courts understand this extreme financial burden that has just been laid upon me on 5/30/2024, requiring me to pay the above-mentioned court fee and costs for 40 booklets (*US Supreme Court Rule 33.1*) due to the denial for me to *proceed in forma pauperis*, would ***certainly require*** at least a 90-day extension in order for me to have the opportunity to proceed with exercising my *Right* to have my day in court.

I further request that the courts see my case which, I have brought to the US Supreme Court Venue, as fact-based and justifiably necessary and ***not*** a frivolous or malicious filing in any such way or manor; thus, granting me this reasonably needed 2nd Motion for An Extension of Time to File by at least 90 days minimum from 6/12/2024.
