Pursuant to Supreme Court Rule 18.2, Applicant Nancy Landry, in her official capacity as Secretary of State of Louisiana, by and through undersigned counsel, hereby gives notice that she has no interest in the outcome of the appeal in the above-captioned matter. Secretary Landry, as a party below, appealed the district court's order and joined the State of Louisiana's Emergency Motion to Stay because of the May 15, 2024 firm deadline by which Secretary Landry needed to receive redistricting information for Louisiana's Congressional districts for implementation ahead of the 2024 election. *See Add. 10-20; Callais, et al. v. Landry, No. 3:24-cv-00122-DCJ-CES-RRS (W.D. La.)*, at ECF Nos. 82, 217. In the current posture of the case, Secretary Landry has no interest in the outcome of this appeal.
