The Court granted the petitions for writs of certiorari in these cases on December 6, 2024. Petitioners' opening briefs on the merits are currently due on January 21, 2025, the day after Inauguration Day and the change in presidential Administrations. See Sup. Ct. R. 30.1.

In order to allow time for review of the government's brief in the new Administration, the United States, petitioner in No. 24-151, respectfully requests, under Rule 30.4 of the Rules of this Court, an extension of time to and including January 28, 2025, within which to file the opening brief and joint appendix. Petitioners in No. 24-20 request a parallel extension of time. Counsel for respondents consents to these requests. If those extensions were granted, respondents' brief would be due on February 27, 2025. With the consent of counsel for all the parties, we respectfully further request that the time for the filing of respondents' brief be extended to February 28, 2025.
