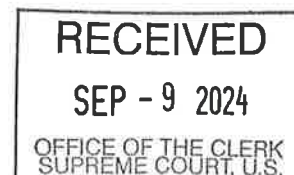

To the **Honorable Annette Ziegler**, as Chief Justice for the Wisconsin Supreme Court OR any United States Justice able to grant this relief.

Pursuant to this Court's Rules 13.5, 22, 30.2, and 30.3, Petitioner RYAN THORNTON respectfully requests that the time to file his Petition for Writ of Certiorari in this matter be extended for 60 days up to and including **December 30, 2024**. Absent an extension of time, the Petition for Writ of Certiorari would be due on October 31, 2024. The Petitioner is filing this Application more than ten days before that date per Rule 13.5.

The Wisconsin Supreme Court denied RYAN THORNTON's 5/8/2024 Petition For Review (App35-42) on August 2, 2024 (App45). This Court would have jurisdiction over the judgment under 28 U.S.C. 1254(1).

RYAN THORNTON is seeking an extension of time in reference to the order dated August 2, 2024 by the Wisconsin Supreme Court in case No. 2023AP02368-W (App45).

Statement of the Case

Ever since Attorney Justin Singleton decided to quit on 1/9/2023 (regarding filing RYAN THORNTON's Appeal of 2019CF397 that he was hired for in 2019), the Court of Appeals (and WI Supreme court) has been rejecting Jurisdiction of reviewing RYAN THORNTON's Appeal of 2019CF397. Since then RYAN THORNTON has filed 3 Appeals to 2019CF397:

1. 2023AP769

a. The State of WI keeps rejecting to formally review RYAN THORNTON's (filed 7/22/2023, recorded as 7/24/2023) [Brief of Appellant] (App2-33)

b. RYAN THORNTON's U.S.S.C. [Petition For Writ Of Certiorari] was denied on 3/25/2024 (No. 23-898)

i. Although RYAN THORNTON believes it to be sufficient and concisely describe the Issue (Issue #1 of 7 Issues that RYAN presents in 2023AP769 & 2023AP1596 & 2023AP2368) with the most legal merit that should command a reversal.

ii. RYAN having to make Certiorari booklets mostly about Attorney Justin Singleton (Issue#7) would steal attention (and Certiorari word count) from RYAN being able to sufficiently explain his primary Issues in 2019CF397 (#1-#6). This Issue that Attorney Justin Singleton created is very tedious for RYAN to explain, especially in U.S.S.C. booklet format.

2. 2023AP1596

- a. Same Issues (#1-7) as in 2023AP769, just deriving from RYAN THORNTON appealing orders that he (apparently) had to make pursuit of at the Circuit Court level, given the state's refusal to accept 2023AP769.
- b. On 6/14/2024 the WI Court of Appeals indicated that 2023AP1596 "has been submitted to the court for consideration" (App44)

3. 2023AP2368

- a. Same Issues (#1-7) as in 2023AP769, just deriving from a 12/12/2023 WI Supreme Court Order that "claims of ineffective assistance of appellate counsel must be brought via a petition for writ of habeas corpus in the court of appeals pursuant to State v. Knight, 168 Wis.2d 509, 484 N.W.2d 540 (1992)" (App34)

The justification for denying RYAN THORNTON's 5/8/2024 2023AP2368 [Petition For Review] (App35-42) on August 2, 2024 (App45) is unclear.

Reasons For Granting An Extension Of Time

The time to file a Petition for a Writ of Certiorari should be extended for 60 days for the following reasons:

1. Making 40 booklets, in the pages required for this Writ Of Certiorari is a lot of work to create on a computer and appendix everything
 - a. Simply reformatting (to U.S. S.C. Booklet Format) what was already stated in Circuit Court, is very tedious.
 - b. It costs time and money to produce, ship, and file.
2. RYAN THORNTON has 2 open lawsuits (that were both filed Pro-Se) and a probate case at Racine county circuit court.

Conclusion

For the foregoing reasons, the Petitioner respectfully requests that the court:

1. That the time to file the [Petition for a Writ of Certiorari] in this matter be extended 60 days, up to and including December 30, 2024.
