To the Honorable Chief Justice of the United States:

Applicant, Martin Akerman, appearing pro se, respectfully requests an additional extension of 52 days to file a petition for a writ of certiorari, extending the current filing deadline from December 19, 2024, to February 9, 2025. The Chief Justice previously granted an extension from December 11, 2024, to December 19, 2024, on September 19, 2024. This application is submitted pursuant to Supreme Court Rule 13.5.

Applicant seeks additional time due to the complexity of the legal issues involved and to allow for coordination with related pending cases that bear directly on the questions presented. These related cases include:

Pending Petition for Writ of Mandamus (No. 24-443):

A petition for writ of mandamus remains pending before this Court, with a response due from the Respondent on November 21, 2024. This matter, along with related petitions in the Federal Circuit (Nos. 2024-146 and 2025-107), involves overlapping jurisdictional and procedural questions central to Applicant's claims.

Related Petition for Writ of Habeas Corpus (No. 24-83):

This petition, pending before this Court and distributed for the November 15, 2024, Conference, involves state habeas corpus issues under Ninth Circuit Case No. 2024-6166. No response has been filed from the federal agencies in that matter, and its resolution may materially impact the grounds for the petition in the instant case.

Pending Petition for Writ of Certiorari (No. 24-339):


This petition, also distributed for the November 15, 2024 Conference without a response from federal agencies, raises critical procedural issues that intersect with Applicant's claims and may provide necessary clarity for the petition in this case.

Applicant requires additional time to fully consider these developments and ensure a comprehensive presentation of the significant jurisdictional and constitutional questions implicated in this case. The requested extension will also allow time to incorporate any relevant findings from the aforementioned conferences and pending responses.

Conclusion

For these reasons, Applicant respectfully requests an additional 52-day extension, for a total of 60 days, to file the petition for writ of certiorari, extending the deadline to February 9, 2025.
