To the Honorable Samuel A. Alito, Associate Justice of the Supreme Court of the United States and Circuit Justice for the United States Court of Appeals for the Fifth Circuit:

Pursuant to Rule 13.5 of the Rules of this Court and 28 U.S.C. § 2101(c), Petitioner John Xavier Portillo respectfully requests a thirty-day extension of time, to and including December 11, 2024 to file a Petition for a Writ of Certiorari in this case. It is therefore respectfully submitted that the application for a thirty-day extension of time to and including December 12, 2024, within which to file a Petition for a Writ of Certiorari in this case be granted.
