Comes now Dale Scott Heineman, Executor/originator/real party in interest, hereinafter Petitioner, files this Stay Requested for this Instant Case as Petitioner has been kidnapped, extorted, and now without Resources to Prosecute this instant matter as Petitioner has been incarcerated for alleged non-payment of restitution, *inter alia*, which is peonage, despite a showing to the government and to Judge William H. Alsup, the administrator of the Northern District Court, California Division, the numerous violations of Petitioner's protected due process rights and of violations of the law.

On October 2, 2024, Petitioner requested from this honorable Court a stay of proceedings by and through Supreme Court Rule 23 until this Instant Matter can be heard regarding the Form 12 sentencing hearing of October 22, 2024, which now has concluded with a term of imprisonment. This occurring despite Petitioner's many attempts to draw to the attention of Judge Alsup and to the government the fatal defects of law and process shown in the record.
