
DECLARATION OF RANDALL L. KALLINEN

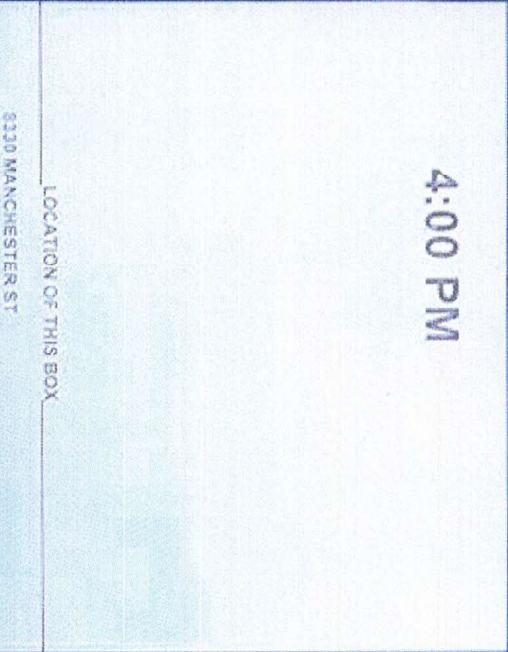

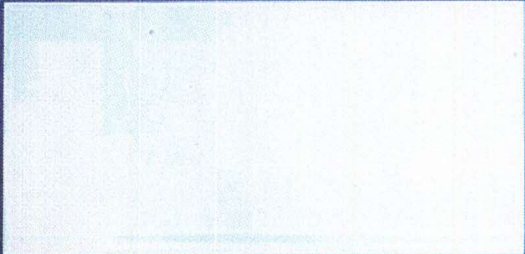
