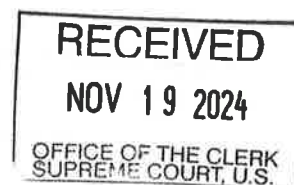

PETITIONER'S MOTION FOR EXTENSION OF FILING DATE


Pursuant to Supreme Court Rule 30(3), Petitioner is requesting an extension of the filing date for his petition for a writ of habeas corpus. This Court has jurisdiction, pursuant to Title 28 U.S. Code § 2101 and Title 28 U.S. Code § 2254

On May 17, 2024 Petitioner filed a petition for a writ of certiorari in the matter of Docket 23-7498 Watson v Pamerson. On October 9, 2024 This Court denied Petitioner's motion for leave to proceed in forma pauperis and dismissed his petition for a writ of certiorari is dismissed, pursuant to This Court's Rule 39.8. On October 29, 2024 Petitioner filed a petition for rehearing en banc in the matter

On July 12, 2024 in the matter of Docket 23-1263 Watson v Fasano, the First Circuit dismissed Petitioner's claims for a writ of habeas corpus. **Attached at 2** On July 14, 2024 Petitioner filed a petition for rehearing in the matter of Docket 23-1263. **Attached at 1** On August 19, 2024 The First Circuit denied Petitioner's petition for rehearing. Pursuant to This Court's Rule 13, Petitioner has, "90 days after entry of the judgment ," to file a petition for a writ of certiorari judgment.



The issues raised in Docket 23-7498 Watson v Pamerson mirror the issues in Docket 23-1263 Watson v Fasano. Therefore, Petition requests an extension for the filing deadline of a petition for a writ of certiorari in the matter of Docket 23-1263 Watson v Fasano. Petitioner requests sufficient time to get a response from This Court on his petition for rehearing in the matter of Docket 23-7498 Watson v Pamerson and 60 days to prepare a a petition for a writ of certiorari in the matter of Docket 23-1263 Watson v Fasano, if necessary.

JUDGMENT

Petitioner-Appellant Lawrence Byron Watson appeals from the order of the district court dismissing his petition for habeas corpus, filed pursuant to 28 U.S.C. § 2254. Where, as here, the district court dismissed Watson's petition on timeliness grounds, we review that decision de novo. Drew v. MacEachern, 620 F.3d 16, 20 (1st Cir. 2010).
