TO THE HONORABLE UNITED STATES SUPREME COURT

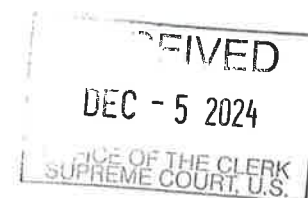
Petitioner files this Motion for Extension of Time to File a civil Writ of Certori for Review In support of this motion, Petitioner shows the following:
