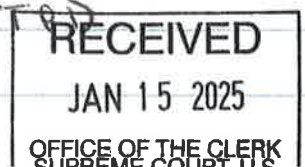
COMES NOW PETITIONER, RANDY DUCK, AND RESPECTFULLY
