RE: Request for extension of time to file petition for writ of certiorari.


In accordance with this Court's Rules 13.5, 22, 30.2, and 30.3, Applicant Daniel Scott Robinson respectfully requests that the time to file his petition for a writ of certiorari to the U.S. Supreme Court be extended for 60 days, up to and including Monday, May 9th, 2025. The Hawaii State Supreme Court issued its opinion on December 12th, 2024 (Exhibit A). Absent an extension of time the petition would be due on March 11th, 2025. The jurisdiction of this Court is based on 28 U.S.C. 1254(1) and 28 U.S.C. 1254(2).

Background

This case presents an important national question concerning the coordinated and blatant criminal violation of citizens civil, disability, and constitutional rights. This, in order to cover up the criminal actions of "state officers" who purposely violated those rights in order to illegally gather more than twelve billion dollars in federal health and human services grant funding which they launder into 501 c3 nonprofit organizations they control by citing "parens patria", or the good of the state, using state rulings on state laws such as Stop Rail Now v. DeCosta, 120 Haw. 238, in violation of civil and disability rights and federal and constitutional law. While this is currently a case located in Hawaii, this pattern of civil, disability, and federal and constitutional law violations is being repeated in states across the country using similar state laws in violation of federal law. The applicant has initiated multiple federal investigations including with the Federal Bureau of Investigation, Federal Health and Human Services as well as the Office of Inspector General for these federal departments. The applicant has submitted multiple motions for stay in the lower court cases pending this petition for writ of certiorari to this U.S. Supreme Court and they are continually denied.

Reasons for Granting an Extension of Time

Good cause exists for the requested extension because the petitioner is a pro se litigant who has had to spend thousands of hours preparing his defense, filing multiple motions, filing multiple appeals, and filing multiple legal complaints including against multiple judges and "state officers" and to the Hawaii Commission on Judicial Conduct in which Judge Mahilani Hiatt had "appropriate action" taken against her for her misconduct (Exhibit B). As a single father caring for his mother with Stage 4 Breast Cancer, 3 young children, and who works to support himself and his family he has limited time to file the petition for writ of certiorari due to the legal onslaught of motions that he has had to defend against as well as what the petitioner believes are illegal actions of the Hawaii "state officers".



Conclusion

The petitioner humbly and respectfully requests that the time to file a petition for writ of certiorari in the above matter be extended 60 days to and including May 9th, 2025.
