THERE IS ZERO LANGUAGE FBI, PIPEFITTERS OR CONGRESS THE ABILITY TO ABUSE THESE JOBS AS BAIT PEOPLE TO TURN AS A REWARD ON PEOPLE. NOT ONE FBI JOB IS IN JEOPARDY A RESULT THIS SITUATION. MEMBERS LOST ASSETS AND PENSIONS A RESULT. CELEBRITIES AS YOUNG AS 16 DISNEY AND NICKELODIAN LIE AGES CLAIMING 18 AND SENT TO JOBS NEW YORK. DEFAMATION IS USED BY FBI AND THRU PEOPLE SCREWING ME. THE SIMPLE FACT A MOTION OF DEFAULT WAS ENTERED BP REFINERY AND TOLEDO FBI SHOWS INTERSTATE SEX TRAFFIC.

OPINIONS:

JURISDICTION:

A UNION MEMBER PAYS MONTHLY DUES ENTITLING THEM TO JOBS. BP REFINERY TURNED AWAY MEMBERS LOCAL 50 FOR TOLEDO FBI TO CRIMINAL SEX TRAFFIC. AS A TRAVELER MEMBERS HAVE RIGHTS STARTING ANY HEAD FBI RIGS ANY STATE. UNTIL FBI WAS STALKING ME THERE WAS NEVER ANY CELEBRITIES A TWO PENSION GAME OR PEOPLE IN CONTACT WITH ME, TURNING ON ME.

CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED:

A UNION MEMBER PAYS MONTHLY DUES TO RECEIVE A RIGHT TO EMPLOYMENT. LOCAL MEMBERS, THEN NEARBY "SISTER" LOCALS, ARE BY HISTORY EMPLOYED FIRST.

18 U.S.C. } 2422- KNOWINGLY ENTICING, INDUCING, COERCING OR PERSUADING SOMEONE TRAVEL IN INTERSTATE OR FOREIGN COMMERCE TO ENGAGE IN SEX ACTS. UP TO 20 YEARS IN PRISON A SENTENCE.

2) INVASION OF PRIVACY IS A TORT BASED IN COMMON LAW, ALLOWING AN AGGRAVATED PARTY TO BRING A LAWSUIT AGAINST AN INDIVIDUAL WHO UNLAWFULLY INTRUDES INTO HIS/HER PRIVATE AFFAIRS, DISCLOSES HIS/HER PRIVATE INFORMATION, PUBLICIZES HIS / HER IN A FALSE LIGHT, OR APPROPRIATES HIS/HER NAME IN A FALSE LIGHT.

FOUR TORTS OF INVASION OF PRIVACY :

- 1) INTRUSION OF A PERSONS SECLUSION OR SOLITUDE
- 2) PUBLIC DISCLOSURE OF EMBARRASING PRIVATE FACTS ABOUT A PERSON.
- 3) PUBLICITY THAT PLACES A PERSON IN A FALSE LIGHT IN THE PUBLIC EYE.
- 4) APPROPRIATION, FOR THE DEFENDANTS ADVANTAGE, OF THE PERSONS AGE OR LIKENESS.

STATEMENT OF THE CASE:

FOR THREE DECADES THE FBI TOLEDO AND DETROIT HAS USED MY LIFE THRU SLANDER AND DEFAMATION. IT STARTED KIM BROOKS SEX TRAFFICKING HER AND DIVORCED MOTHER, HER BROTHER WAS MOVED TO MICHIGAN AS I MOVED TO OHIO. WITHOUT EVEN ARRESTING ME FOR ANY DRUGS THE FBI INTERSTATE RIGGED PEOPLE A PROTECTION GAME. ANY FEMALE I APPROACHED TO THIS DAY, FBI AND POLICE WENT BLOCKING THEM BETWEEN. EVERY FEMALE I WROTE FACEBOOK WAS BLOCKED AND DIVERTED. THEN CRAIGSLIST WEBSITES SAME INTERSTATE GAMES. NO MATTER WHAT INTENTION TO ENGAGE IN SEX, ANY INDIVIDUAL HAS THIS RIGHT. PEOPLE WERE TOLD TO WRITE STATEMENTS, THEN FBI AND CORRUPT JUDGES COIRCED FEMALES TO TURN ON ME PROMISED PIPEFITTER JOBS, PENSIONS AND SEX MANY MEN RIGGED. IN 30 YEARS I COULD HAVE RAISED A FAMILY , THIS STARTED 1992.

REASONS FOR GRANTING THE WRIT

FROM RACE TO SEX TO RELIGION, ANYONE HAS A RIGHT TO ENGAGE IN SEX . SOME WANT ONE NIGHT STANDS, SOME A RELATIONSHIP, SOME STRAIGHT SEX, BISEXUAL SEX, IT S UP TO THE INDIVIDUALS. THE FBI IS DOING THIS A PERVERT WATCHING CREATED COIRCED SEX ACTS. THE SIMPLE FACT A MOTION OF DEFAULT WAS ENTERED A LOWER COURT, THOSE 80,000 A YEAR JOBS/SHOULD HAVE BEEN TERMINATED.

MY OBJECTIVE THRU SUING IS REMOVING HEADS SO EMPLOYEE INVESTORS TAKE OVER AS A MASS THRU STOCK INVESTORS. NOBODY NEEDS AN FBI THEIR PROTECTION OR SEX DATING SERVICE. HOW WOULD YOU LIKE THE FBI STALKING, SEXING, DEFAMATION AND SLANDER, TO PREVENT YOU FROM ANY FINANCIAL GAIN, PENSION, SEXUAL INTIMATE RELATIONSHIP, AND FRIENDS AS THEY TURN THEM ON YOU AS ANY YOU MAKE. EVERYTHING IS CONDUCTED WITHOUT KNOWING THEIR IDENTITY AND CONVERSATIONS BLOCKED FORCED RAPE ANY FEMALES.
